FORMS of PAYMENT: CASH, CHECK, ZELLE

- **SPEED LIMIT: 5 MPH.** PLEASE WATCH FOR CHILDREN!
- **PARKING:** ONLY 2 VEHICLES PER RV SITE. NO LEAKING VEHICLES. DO NOT PARK ON THE GRASS. PLEASE NOTIFY MANAGEMENT IF ADDITIONAL PARKING IS NEEDED.
- **SITE MAINTENANCE:**
 - a. OUTSIDE STORAGE AROUND OR UNDER RV STRICTLY PROHIBITED.
 - b. NO CLOTHESLINES PLEASE.
 - c. PLACE ALL GARBAGE IN BAG AND PLACE IN DUMPSTER.
 - d. LAWN MAINTENANCE IS PROVIDED BY MANAGEMENT. PLEASE KEEP SITE CLEAR OF OBSTACLES.
 - e. HOSES AND CORDS MUST BE WELL MAINTAINED WITH PROPER HOOKUPS AND ATTACHMENTS.
- **MINORS:** PARENTS ARE RESPONSIBLE FOR THE WHEREABOUTS, SAFETY, AND CONDUCT OF THEIR CHILDREN AT ALL TIMES.
- **PETS:** FRIENDLY DOGS (NO LARGER THAN 35 POUNDS) ARE WELCOME BUT ARE TO BE ON A LEASH NO LONGER THAN 6 FEET AND ATTENDED AT ALL TIMES BY A RESPONSIBLE PERSON, WHO SHALL CLEAN UP AFTER THEM IMMEDIATELY. NO EXCESSIVE BARKING ALLOWED.
- **ALCOHOL & DRUGS:** DISORDERLY CONDUCT AND INTOXICATION WILL NOT BE TOLERATED. ANY AND ALL ILLEGAL SUBSTANCES ARE STRICTLY PROHIBITED.
- **FIRE HAZARDS:** DO NOT LEAVE ANY OPEN FIRES UNATTENDED. NO FIREWORKS ON PREMISES.
- **ADDITIONALLY:** RULES AND GUIDELINES POSTED IN SPECIFIC AREAS & BUILDINGS MUST ALSO BE FOLLOWED.
